

Questions and Answers Certification "IIOM Associate Grade



To what extent is the multiple choice test expected?

There are about 80 questions to answer to each of which there are 4 answers. Only one of the possible answers can be correct.

What weighting is there for passing the certification?

The following requirements must be met:

- "PASS" multiple choice test, meaning at least 80% correct answers
- "PASS" OMP (obsolescence management plan) preparation, meaning submission of the OMP before the course
- "PASS" OMP presentation, meaning presentation of the OMP during the course
- "PASS" OM Process capability, meaning, active participation in collaborative process design during the course

If a "PASS" is missed, so a "FAIL" is issued, the course is considered failed but can be repeated.

Is it possible to fail is general or fail due to test results?

It is possible to fail. If one of the above requirements is not met with a "PASS", the course is considered failed, but can be repeated.

How many participants are allowed per certification course?

The maximum group size is 12-15 people.

Who exactly is represented in the team of certifiers?

The team of certifiers consists of employees of AMSYS GmbH as well as the trainer. AMSYS GmbH has been appointed "ENDORSED TRAINER" and has been thoroughly evaluated by an independent IIOM committee in order to issue this certificate. No member of the IIOM Committee have any connection with AMSYS GmbH, and there is no conflicts of interest.

How extensive is the knowledge required from the 2-day course? If I look through the script I would not know exactly what I should learn.

The certificate obtained at the end of this course is an Obsolescence Manager qualification, which proves a very good understanding of the topic. Thus, a comprehensive knowledge will be queried. Are the OMPs and processes to be recreated based on a sample project, or are you specifically presenting own documents and processes that you have developed on the basis of the 2-day seminar?

Here you are free! Participants must develop an Obsolescence Management Plan (OMP) draft for a project they are working on. Alternatively, the participants are instructed to write an OMP for a sample project of the trainer.

What are further prerequisites to be able to use the post-nominal letters "AIIOM" after the own name?

A student does not have to be an IIOM member before or after attending the IIOM certificate on course. However, if a participant wishes to use the post-nominal "AIIOM" letters after the own name, they must be an IIOM member, which costs £ 120 a year, plus a one-time registration fee of £ 125.
